ELECTION OF LEPC OFFICERS

With the recent announcement of former LEPC Chair Jeff Patterson's departure/retirement, a new LEPC Chair and Vice-Chair must be elected to fulfill the remainder of the two-year terms of LEPC Chair/Vice-Chair previously ratified by the State Emergency Response Commission. The term will run through the August 22, 2018 LEPC meeting. A new election (or re-certification) of Officers will be conducted at that time.

Nominations were solicited for these positions in association with the February 22, 2017 LEPC meeting and a nomination deadline of Friday, May 5, 2017 was established. While it was acknowledged that Scott Ehlers (Fire Chief/Clearwater Fire Rescue) and Sandy Brooking (Special Operations Coordinator/Pinellas County EMS & Fire) expressed an interest in pursuing the LEPC Chair position and that James Johnston expressed a desire to retain the role of Vice Chair, no other nominations were subsequently received. As was instructed, no nominations would be accepted following the deadline nor from the floor on the day of the LEPC meeting.

LEPC staff will pass out ballots to the LEPC membership to elect the next Chair. Please note that each entity represented on the LEPC will be allowed one vote, meaning that if an entity's Primary and Alternate are both present, only the Primary should cast a vote. However, if an entity's Primary LEPC member is absent and the LEPC Alternate is present, the Alternate is entitled and encouraged to vote. All ballots will be collected immediately and tabulated promptly. The election winners will be announced prior to the end of the meeting.

CSB 2016 IMPACT VIDEO

The U.S. Chemical Safety Board (CSB) recently released a 2+ minute video characterizing their various accomplishments in 2016. Most of their success over time is due to their extensive Outreach program and efforts, educating first responders, businesses and residents alike of the dangers associated with hazardous materials. Noting that the CSB always acts in an advisory capacity, their thorough investigations following hazardous materials incidents typically result in a series of recommended safety measures for industry to implement and/or recommended enactment of safety measures at the federal level.

MANATEE COUNTY SULFUR FIRE

On Wednesday, April 26th at approximately 7:30 PM, a sulfur fire was reported at Port Manatee (2054 Piney Point Rd.). As part of the response efforts, portions of U.S. 41 were closed in both directions due to “low visibility conditions” being created in the area. The Manatee County Hazmat Team, Sheriff's Office and local fire departments were among those that responded to the incident. It was determined that the fire “might have been possibly caused by the dryness or possible spontaneous combustion issues where the sulfur pile is offloaded at the port.”

Much of the incident was captured by drone film footage. LEPC member Chris Gould, who participated in the response efforts, will provide more detail and characterize the incident.

U.S. Chemical Safety and Hazard Investigation Board



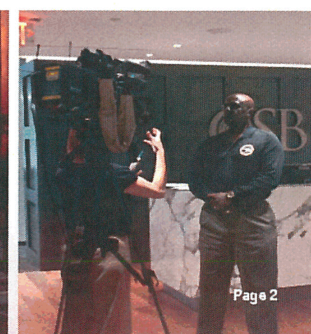
- *The Budget Blueprint to Make America Great Again* states that "A budget that puts America first must make the safety of our people its number one priority – because without safety, there can be no prosperity."
- The U.S. Chemical Safety and Hazard Investigation Board (CSB) is one of 19 agencies proposed for elimination in the budget. Of the 19 agencies targeted, **the CSB is the only agency that has a safety mandate.**
- The CSB was created by Congress, under the Clean Air Act Amendments of 1990, "to investigate accidents to determine the conditions and circumstances which led up to the event and to identify the cause or causes so that similar events might be prevented."
- The CSB is a **unique** agency, modeled on the U.S. National Transportation Safety Board. The CSB investigations identify the **root causes** of chemical incidents and share these findings broadly across industries to **prevent** future incidents. Investigations routinely involve scientific peer review to confirm facts, analysis and conclusions. No other Federal agency or private entity performs this type of comprehensive investigation.
- The CSB mission is to drive chemical safety change through **independent** investigations to protect people and the environment.
- The CSB is an independent, **non-regulatory** agency. While other agencies such as the Environmental Protection Agency (EPA) or the Department of Labor/Occupational Safety and Health Administration (OSHA) have a rulemaking and enforcement role, Congress specifically directed that the CSB be completely independent from these agencies. In fact the legislative history states that the investigations conducted by EPA, OSHA and others "with dual responsibilities tend to focus on violations of existing rules and the cause of the accident almost to the exclusion of other contributing factors for which no enforcement or compliance actions can be taken. The purpose of an accident investigation... is to determine the cause or causes of an accident whether or not those causes were in violation of any current and enforceable requirement."
- The CSB investigations are **transparent**, with investigative materials available on the agency's website. The CSB conducts on-scene press briefings and public hearings to share its findings, obtain additional facts and to hear public concerns.

AGENCY ROLES AND RESPONSIBILITIES

- There is no civil or criminal liability associated with a CSB investigation. The CSB only issues **recommendations** to prevent incidents from occurring. The CSB examines the role of both the regulator and the regulated in its investigations and makes recommendations to both.
- The CSB has investigated over 130 major chemical incidents and issued 788 safety recommendations, 78% of which have been closed.
- The CSB products (e.g. safety reports, recommendations, bulletins, and videos) are routinely used and cited in training throughout the industrial community, academia and professional associations, first responders, labor, and community leaders. The safety videos accompanying major investigative reports are posted on the agency's website and digital platforms. The CSB's award-winning video program has produced 68 video products that have been viewed more than 6.4 million times. The agency's YouTube account has nearly 20,000 subscribers.
- The CSB operates on a budget of \$11 million and a staff of 40, which has remained relatively flat for nine years. The CSB leadership is committed to improved management metrics and accountability to ensure that investigations are completed in a timely manner. The CSB adopted a new strategic plan; engaged in an organizational assessment to identify needs and is currently working on implementing the recommendations. Since 2016, the agency has closed 34 of 37 open inspector general recommendations.
- In the 2016 Federal employee viewpoint survey (FEVS), the CSB was one of the top five most improved agencies, for agencies with 100 or fewer employees. The CSB leadership takes the FEVS seriously and has conducted listening sessions with staff to understand the rankings. Moreover, the agency has committed to supporting the staff with professional and leadership development training, and creating a workforce improvement committee.

**RECAP OF THE MAY 9, 2017
STATE EMERGENCY RESPONSE
COMMISSION MEETING**

The May 9, 2017 SERC meeting was held at the Cocoa Beach Hilton in Cocoa Beach, FL. The Recap summarized below was enhanced by discussions/dialogues which ensued at the May 8th meetings of SERC's Training Task Force and the LEPC Staff & Chairs. The SERC meeting was chaired by FDEM Assistant Director Leo Lachat. The meeting was called to order at 10:02 a.m. and proceeded with the Pledge of Allegiance and a roll call of SERC members.

Although not previously placed on the Agenda, the first order of business was provided by SERC member Chris Rietow (representative of the Regional Planning Councils). Mr. Rietow presented an award to SERC member Richard Delp (representative of the LEPCs) for his 20 years of service as LEPC Chair for the West Florida LEPC.

APPROVAL OF MINUTES

The January 18, 2017 SERC meeting *Minutes* were approved unanimously upon voice vote.

NEW BUSINESS

- **LOCAL EMERGENCY PLANNING COMMITTEES APPOINTMENTS** - Meeting Chair Leo Lachat requested approval of membership modifications recognized for each LEPC. SERC unanimously approved all changes requested by each of the LEPC Districts upon voice vote. The membership changes for the Tampa Bay LEPC approved during the quarter were the redesignation of Primary/Alternate for the Hillsborough County Fire Rescue (*Doug Shirley/Holley Wade*) and the Southwest Florida Water Management District (*Patrick Casey/Diana Koontz*). In, addition, Mr. Jevon Graham was appointed as the Alternate for Scott Ehlers (Clearwater Emergency Management/Fire Rescue), Mr. Paul Ward was named as the Alternate for Jonathan Kemp (Tampa Bay Times) and Mr. Brant Wilson was assigned to be the new Alternate for Todd Dial (Brenntag Mid-South).
- **AUDIT/INSPECTION WORK PLAN FOR THE RISK MANAGEMENT PLAN (RMP) PROGRAM FOR FISCAL YEAR 2017-18** - FDEM Staff (Robert Dietrich) provided a proposed schedule of RMP audits/inspections for conduct during FY 2017-18. The proposed schedule of audits/inspections were approved unanimously by voice vote. While three inspections will be conducted for various RMP facility across the State, the following constitutes the RMP inspection schedule of the Tampa Bay LEPC District facilities:

REPORTS

- **SERC TRAINING TASKFORCE REPORT** - The following highlights of the May 8th TTF meeting were identified by Jonathan Lamm:
 - **2017 Hazmat Symposium.** Jonathan Lamm identified various parameters associated with the success of the 2017 Hazmat Symposium in Daytona Beach on January 17-20, 2017. The following constitute some of those highlights:
 - ☞ Symposium consisted of 51 Courses (i.e. 19 Hands-On/32 Classroom) with 168 Hours of training instruction were provided by 53 Instructors;
 - ☞ 333 attended the training in 2017, an increase of ~14% compared to 2016 attendance figures;
 - ☞ The Opening Ceremony and welcoming was provided by Mike Callan, a “world-renowned leader in hazmat response”;
 - ☞ Nine Teams competed in the Hazmat Team competition. Individual Awards won by different members of West Palm Beach Fire Rescue and St. Johns County Fire Rescue won the best Team Risk Assessment, best Team Leak Control & Team Overall awards;
 - ☞ Allowed vendors to sell and display products they offer; and
 - ☞ Indicated that the registration associated with the 2018 Hazmat Symposium may open as early as September 2017. A “Call for White Papers” (i.e. proposed instructors/courses) has recently been distributed/requested.
 - **Hazmat Team Self-Assessments.** Mr. Scott Chappell (Florida State Fire College) has coordinated with the ten LEPCs to administer the Self-Assessment of all Florida Hazmat Teams, whether they are considered a funded Regional Response Team or a local team with limited capabilities. Regardless, it is requested that all Surveys be collected by October 2017 and the site visit component of the surveys be conducted on a three-year rotational basis. Those site visits anticipated for 2017 shall be conducted prior to October 1st. The remainder of the site visits can be accommodated over the next two years. Mr. Chappell has agreed to assist the LEPCs in this endeavor to the extent necessary. Mr. John Kohnke suggested attempting to coordinate the site visits with Domestic Security Coordinating Group (DSCG) since they will also be submitting a separate survey with follow-up site visit component.

In the Tampa Bay LEPC District, the following were identified as these Teams: Citrus County, Hernando County, Hillsborough County, Manatee County, Pasco County, Pinellas County, City of Tampa and the 48th Civil Support Team.
 - **Project Tracking Chart.** Matt Marshall (TTF Chair) indicated that the “boxes” associated with the TTF’s *Project Tracking Chart* will need to be individually evaluated and updated. It is anticipated that this will occur in conjunction with the next Conference Call (i.e. status of Shipboard Hazmat Response will need to be updated to reflect the status of the MOU between USCG & FDEP. This Chart will need to be continually updated to be effective. The next conference call has been scheduled for Wednesday, June 21st at 1:30 PM.
- **HAZARDS ANALYSIS WORKING GROUP.** Mr. Dwayne Mundy (Chair of HAWG and member of the North Central Florida LEPC) indicated that a survey was sent to more than 1,000 people pertaining to Hazards Analyses data. A total of 261 responses were received. Here were some of the survey results and findings:

- ☞ Section 302 facility list management for Hazards Analyses site.
- ☞ Develop a process whereby correction to Tier II information and Reports are accommodated timely and correctly.
- ☞ More useful structuring and sharing of HA data for responders and emergency management as well as linking E-Plan and HA data.

- SERC member David Mica suggested finding out the names of fire departments that are not familiar with or participating with LEPCs. John Kohnke identified that there are about 420 fire departments in the State with varying magnitudes of size and capabilities. Only want to coordinate with those that can bring something to the table. Chris Rietow indicated that a lot of Volunteer fire departments do not have access to e-mail so mailings would be required. Membership within these departments are frequently changing.

- **Financial Status Report.** As informational, Mr. Robert Dietrich indicated that the SERC Agenda materials contained numerous tables and graphs depicting program revenues over the past three years and expenditures over the past two years. Revenues have remained relatively constant. This year, facilities can pay all Tier II, RMP & TRI fees online. Last year, more than 11,000 statewide facilities made their EPCRA/Tier II payments online. Expenditures are associated with Hazardous Materials Planning and RMP Programs. The programs annually combine for nearly \$2.4M in revenue. The largest expenditures are FDEM staff and LEPC Contracts. The following reports were included as part of the Agenda materials:
 - Monthly RMP & EPCRA program revenue allocations since mid-FY 2014-15; and
 - Breakdown of General Appropriations and Expenditures by Category for the Hazardous Materials Planning Program and the Risk Management Program during FY 2015-16 and 2016-17 (through February 28, 2017).
- **Hazardous Materials Incidents Reports.** As informational, Mr. Robert Dietrich indicated that detailed listings of Section 304 investigations, fixed facility and transportation-related hazardous materials incidents were prepared and included with the Agenda materials to describe incidents occurring between the period of December 1, 2016 - February 28, 2017. Such Reports included documentation of these incidents and portrayed the number of persons evacuated, injured or deceased down to LEPC District and ultimately County levels. These are all incidents reported to the State Watch Office and are broken down into different categories. This data can be manipulated in any form or fashion.

The following constitutes a consolidation of data associated with “*Transportation Incidents with Evacuations, Injuries and Deaths; Hazardous Materials Incidents with Evacuations, Injuries and Deaths [at fixed facilities]; and Potential Section 304 Investigations*”:

- **Update on FDEM Staff Activities and Reports by Section.** Mr. Robert Dietrich indicated that various graphics were provided within the SERC Agenda materials to depict various staff functions and initiatives.

Information was provided in the Agenda materials to portray:


- annual enumeration of statewide *Hazardous Materials Incident Reports* since 2002;
 - breakdown of statewide *Hazardous Materials Incident Reports* by LEPC District and type from December 1, 2016 - February 28, 2017;
 - monthly enumeration of Hazardous Materials Incident Reports from January 2007 to current;
 - quantification of *E-Plan Filings* for 2016 by LEPC District (as of April 3, 2017);
 - monthly quantification of Technical Assistance calls received from March 1, 2016 - February 28, 2017; and
 - annual enumeration of Tier 2 Data in E-Plan since 2011 in terms of the # of statewide facilities and # of chemicals as of April 3, 2017. Reporting year 2016 Tier II data currently denotes 10,649 facilities in Florida with a total of 31,140 chemicals.
- **Update on LEPC Activities.** While Mr. Richard Delp did recognize that many of the topics addressed at today's SERC meeting were similarly addressed during yesterday's LEPC Staff & Chairs meeting, the following additional matters were discussed:
 - **New LEPC Chairs.** It was identified that two new LEPC Chairs have been designated within Florida during the quarter, one for the South Florida LEPC (Ray McDonald) and one for the Treasure Coast LEPC (Frank Lasaga).

- **Contract Changes.** Chris Rietow (Executive Director from Apalachee RPC & RPC representative on SERC) has been working with Linda McWhorter and Robert Dietrich on potential modifications to LEPC Contracts. Nothing is definitive at the present time. It is anticipated that future LEPC Contracts will be performance based and will require less documentation and paperwork to process reimbursements. Changes may be implemented as early as the FY 2017-18 Contracts. The additional LEPC funding request was not acted upon by the legislature.

Mr. Delp concluded his remarks by recognizing his hopes that the recent changes to FDEM personnel will not result in a reduction of support and aid to the LEPCs in administering their functions. Mr. Delp additionally encouraged all to review the Hazmatters reports prepared by the LEPCs (for their respective Districts) that were included in the SERC Agenda materials.

The following was identified for the Tampa Bay LEPC District for the period of January - March 2017:

- Tampa Bay LEPC staff was involved in a number of activities during the quarter. Staff attended the SERC quarterly meetings held at the Plaza Resort and Spa in Daytona Beach on January 17-18, 2017. The quarterly Tampa Bay LEPC meeting was held on February 22nd.
- In conjunction with the February 22nd Tampa Bay LEPC meeting, Chair Jeff Patterson unexpectedly announced his retirement and resignation from the LEPC effective March 3rd. Chair Patterson will be missed by all. Chief Patterson has served on the Tampa Bay LEPC since his initial appointment in July 2012, as staff to Hillsborough County Emergency Management. Shortly following his acceptance of a *Special Operations Chief* position with Hillsborough County Fire Rescue, Mr. Patterson was elected to serve as LEPC Chair from February 2014 until his recent retirement announcement. An election of the next LEPC Chair will be held in association with the May 24th Tampa Bay LEPC meeting.
- The Tampa Bay LEPC's HMEP Training Subcommittee also met on February 22nd to strategize expenditures associated with the FY 2016-17 HMEP Training contract. Training needs and desires were identified for each of the LEPC's six Counties, which were all present. It was identified that FY 2016-17 HMEP Training expenditures commenced by sending 27 to attend the 2017 Hazmat Symposium in Daytona Beach. Three, shift-friendly, three-day, 3-Hr. *Responding to Gasoline Tanker Emergencies* courses have been/will be scheduled for conduct in May – June at various locations within the District. The following additional training courses were identified as needs and may be solicited: three 8-Hr. *Advanced Hazmat IQ* Courses & a 40-Hr. *Toxmedic/Hazmedic* (cost share with Pinellas County); 8-Hr. Chlorine and 8-Hr. Ammonia "Technician Level" courses (Manatee County); 8-Hr. Chlorine and 8-Hr. Ammonia "Awareness Level" courses as well as a 4-Hr. Air Monitoring course (Pasco County); four students to attend 160-Hr. *Hazmat Technician Certification* course at Florida Fire College (Hernando County); a 3-Hr. *Hydro Carbon* course (City of Tampa); and an 8-Hr. *Street Smart for Hazmat* Course (Districtwide).
- In terms of miscellany, LEPC staff additionally: e-mailed Flyers regarding Tampa Bay LEPC's EPCRA HTC/E-Plan Filing Instructions Workshops to more than 2,700 individuals (January 6th); attended the bi-monthly meeting of the Tampa Bay Spill Committee (January 10th & March 14th); various LEPC members attended the (nearly) monthly meetings of the Ammonia Handlers/Operators (January 10th, February 21st & March 23rd); facilitated the (nearly) monthly meeting of the Pinellas Police Standards Council (January 11th & March 8th); participated in the (nearly) semi-quarterly teleconference of SERC's Hazards Analysis Working Group (January 12th); prepared and distributed SERC Recap to LEPC members, TBRPC members and members of the LEPC's Facility Disaster Planning Subcommittee (January 26th); attended the annual *Port Tampa Bay Safety Summit* (February 1st); hosted and conducted the 2017 Emergency Planning and Community Right-to-Know Workshops at the Tampa Bay Regional Planning Council (February 6-7); participated in the (nearly) semi-quarterly teleconference of SERC's Training Task Force (February 15th & March 15th); attended TBRPC's *Regional Transportation Summit* (February 16th); attended the grand opening ceremony of the Hillsborough County Public Safety Operations Complex (February 23rd); participated in 2017 Hernando County FDOH exercise *Concepts & Objectives Meeting* (February 24th) and *Initial Planning Meeting* (March 21st) via teleconference; attended the 2017 Port Safety Funfest planning meetings (March 1st & March 22nd); provided a box of 2016 *Emergency Response*

Guidebooks to Tampa Fire Rescue (March 14th); and attended the triennial meeting of the USCG's Area Contingency Committee (March 28th).

OTHER BUSINESS

- **National Association of Sara Title III Program Officials (NASTTPO).** President Tonya Ngotel provided the following highlights of the NASTTPO:
 - ☞ Their mission is to serve the SERCs and LEPCs nationwide.
 - ☞ Holds an annual conference at various locations and a mid-year conference, typically in Houston, TX.
 - ☞ They typically lend support through changes to fundamental regulations.
 - ☞ 70% of States are represented at this meeting in Cocoa Beach.
- **FDEP Pollution Notification Rule.** Mr. John Johnson indicated that the Responsible Party (RP) of a hazardous material release below the Reporting Quantity (RQ) has 24 hours to notify the FDEP of the incident. After which, FDEP will provide the further notification requirements. Releases above the RQ still remain the obligation of the RP to notify the State Watch Office (SWO) and National Response Center within 15 minutes of the incident. In turn, the SWO will notify FDEP of such incidents.
- **Small Quantity Generator (SQG)/Large Quantity Generator (LQG) Rule.** Revisions to the SQG/LQG Rule were proposed whereby additional interaction and involvement with the Local Emergency Planning Committees, local Fire Departments and Emergency Management agencies would be required. The revisions also included an increased exercise schedule and associated parameters. These revisions have currently been "tabled" until at least 2019.
- **FDEM Staff Changes.** Mr. Robert Dietrich identified that the *2016 SERC Annual Report* has been published. Mr. Paul Wotherspoon is no longer with FDEM. Most of the changes are management related as they attempt to "streamline" the Division. Mr. Dietrich will be tasked with the programmatic responsibilities. Linda McWhorter is still involved. Donna Ray OR Isabell Parker will be at all future SERC meetings. Two additional RMP inspectors have been requested for FDEM. So far, the outlook of their funding looks likely. If hired, these individuals will be assigned additional duties such as EPCRA outreach. Please continue to contact Mr. Sam Brackett (or Robert Dietrich) with any alleged non-filing facilities.

COMMENTS

- Meeting Chair Lachat mentioned that the Governor recently enacted an Executive Order regarding the wildfires being experienced in Florida. The State EOC has been placed on a Level 2 activation. Most wildfires are occurring towards the central portion of the State. There is currently a big fire at the Florida/Georgia border. Florida Forestry and others have been and will continue to respond. Federal firefighting grant funds have recently been solicited and awarded to aid and assist with response. Additionally, a statewide hurricane exercise was conducted last week. The scenario involved the threat of two hurricanes (Gonzales and Coleman). It was determined that the exercise went very well and was believed to benefit all the participants.

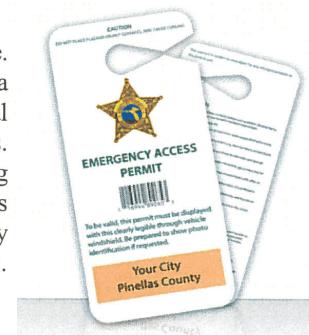
Attendees Present - Joe Mastandrea (LEPC Member/Hillsborough Emergency Management), Rick Walker (LEPC Member/Pinellas Emergency Management), Wes Morse (LEPC Member/Port Tampa Bay), Dennis Martin (Port Tampa Bay), Denise Lynch (CSX), Gary Dunmeyer (Harcros Chemicals) and John Meyer (LEPC/ FDPS Staff Coordinator).

1. **INTRODUCTIONS/ANNOUNCEMENTS.** Mr. Meyer welcomed and thanked the Subcommittee members for their attendance.
2. **UNIVERSAL BADGING/CREDENTIALING.** Mr. Meyer acknowledged that the intent of this initiative is to ascertain the Re-Entry procedures/processes being implemented in Pinellas County, the City of Tampa and Hillsborough County following a natural or man-made disaster. As it pertains to the LEPC program, enabling efficient access of “essential” personnel of facility hazardous materials is likely critical to allow them to access and assess their facilities and inventories in order to safeguard property and lives. At the conclusion of this initiative, it will NOT be the role or intent of the LEPC (or the FDPS) to regulate any procedures or specific processes, only make recommendations to key personnel. The Subcommittee remains optimistic that the goal of this initiative is to promote the use of a universal badging system that can only appropriate personnel efficient access through the various checkpoints that are anticipated for a multitude of law enforcement agencies.

PINELLAS COUNTY

While Mr. Nick Lazaris (Pinellas County Sheriff’s Office) was unable to attend the meeting to make his presentation, a thorough overview of Pinellas County’s Re-Entry plan was alternatively provided by Mr. Rick Walker (Pinellas County Emergency Management). The highlights of Mr. Walker’s presentation were as follows:

- PCSO started talking about badging concept for quite some time. They proceeded to test this concept through the implementation of a badging program for the Barrier Island communities with the annual requirement for registration (or re-registration) by residents. Consideration may now be directed towards the manufacturing industry within the County not located on the barrier islands. It is anticipated that such effort would be coordinated through the Bay Area Manufacturing Association (BAMA) and other similar entities.

- The Pinellas County Re-Entry procedures would need to be coordinated with Pasco and Hillsborough officials since they host the major access points to Pinellas County. To a lesser extent, coordination with Manatee County officials would also occur although their only access point to Pinellas County is across the Sunshine Skyway Bridge.
- Anticipated Registration Process - Would need to bring a letter from high ranking company official on company letterhead indicating individual by name and rank and the desire to allow this individual to access facility expeditiously following as disaster to perform site/facility assessment and potential mitigation. Also required would be the person's driver's license and a company ID.
- In terms of Pinellas County facilities presently having hazardous materials, 192 facilities use, produce or store Extremely Hazardous Substances and another 270± facilities possess one or more hazardous materials as defined by the U.S. Environmental Protection Agency. To the greatest extent possible, Pinellas County Emergency Management will provide Pinellas County Sheriff's Office a listing of all names of company representatives listed in the E-Plan electronic hazardous materials reporting database in order to provide an additional level of security to match up against at the checkpoint locations.
- In Pinellas County, all law enforcement agencies work under the Pinellas County Sheriff's Office when implementing re-entry procedures. Once an individual clears a particular checkpoint(s), they will be provided a designated route to access their facility, based on debris clearance operation, or will be directed to a Central Staging Area. While debris clearance operations will be guided by the Sheriff's Office and/or Emergency Management, highest priority will be given to the mobility of firefighters and access to the local hospitals. It will be critical to maintain a good working relationship with power company(ies) to ensure downed power lines are efficiently addressed and restored to the quickest extent possible.
- Mr. Walker encouraged company "decision makers" and other high ranking officials to subscribe to the Wireless Priority Service (WPS). Users of such service would be granted "priority in the call queue" in the event of congestion in the wireless network. It appears that all major cell phone companies offer WPS.
- More information on the present Pinellas County Re-Entry procedures is available from the Pinellas County Sheriff's Office website (www.pcsoweb.com/emergency-access-permit). It is anticipated that future updates of Pinellas County's re-entry procedures will be additionally posted to this website.

It is hereby acknowledged that *"badging is a consideration in future planning but building a system is still not a County EM or Sheriff's priority at this time."*

CITY OF TAMPA

Mr. Meyer acknowledged recently obtained a copy of the City of Tampa's Re-Entry procedures from Tampa Emergency Management staff. In turn, Mr. Meyer prepared the following highlights of Tampa's Plan:

- Re-Entry Policy – *“The Re-Entry Policy is designed to prohibit citizens from accessing evacuated areas until all life-threatening hazards are eliminated. The Policy is also designed to regulate entry to protect public safety, public health and private property.”* As further identified, potential hazards would/could include hazardous materials.
- Re-Entry will not be allowed until areas are deemed “safe” as determined by representatives from law enforcement, fire, building, utilities & health. Tampa Police Department (TPD) will restrict access until clearance provided.
- TPD’s Special Incident Management Unit will determine location(s) to restrict entry.
- Individuals will need to obtain “Entry Passes” from personnel of Public Works & Parking Division at Pre-Determined Fixed Re-entry Points or Mobile Re-Entry Points.
- TPD will manage Re-Entry Points with guidance from the TPD Command Post.
- Police, Fire, Military, National Guard as well as “Essential” personnel will be granted access once cleared by Incident Commander.
- Citizens/residents will be granted access with “proper credentials” AND cleared by Incident Commander.
- Three levels of Re-Entry: No Re-Entry, Limited Re-Entry and Unlimited Re-Entry
- The “Limited Re-Entry” would be subject to a curfew and *“would allow residents and property owners to conduct temporary visits to their property to remove valuables, protect undamaged property and perform repairs or further protect damaged property and obtain assessment information for insurance claims.”*
- No Re-Entry will be authorized for condemned structures.
- *The ‘proper identification’ of residence, business owners and critical employees is left to the discretion of the police supervisors at the processing points. Common acceptable forms of ID include a driver’s license, identification card or utility bill with an address within the limited re-entry area... The Hookers Point area also has several forms of ID that are specific to its location such as the Port of Tampa ID card and Transportation Worker ID Credential (TWIC). Passes are likely to be issued in three colors: RED, ORANGE & YELLOW, dependent on level of Re-Entry Phase.*

HILLSBOROUGH COUNTY

Mr. Meyer acknowledged that he has been unsuccessful at obtaining a copy of Hillsborough County's existing Re-Entry program procedures although they are known to exist. Through perseverance and persistence, Mr. Meyer anticipates receipt of such document/procedures shortly. The meeting was adjourned at 1:02 p.m.

The Tampa Bay LEPC's FY 2016-17 HMEP program runs between October 1, 2016 - December 30, 2017. The purpose of the extended Contact period is to align the State and federal funding cycles. Consistent with prior HMEP Contracts received, the federal funding shall be used to assist in meeting the hazardous materials training needs of public-sector first responders employed in the Tampa Bay LEPC's six member Counties and their associated Cities. Nominal "Course Management" fees will continue to be reflected in most courses. Albeit a 15-month Contract period, this year's allocation is \$74,564. The expenditures associated with the FY 2016-17 HMEP Contract are identified in *Exhibit 5* (i.e. **Page 24** of these Agenda materials)

While courses continue to be discussed, vetted and coordinated through the LEPC's HMEP Training Subcommittee, the only expenditures thus far are in association with the funding of 27 to attend the 2017 Hazmat Symposium in Daytona Beach from January 17-20, 2017. Interest has been expressed for the conduct of Gasoline Tanker courses in each County of the District.

In addition, the following have been identified in terms of local training desires:

- Hernando - 4 Students to attend the 160-Hr. *Hazmat Certification* Course
- Manatee County - 8-Hr. Technician-Level Chlorine & Ammonia Courses
- Pasco County - 8-Hr. Awareness-Level Chlorine & Ammonia Courses and a 4-Hr. *Air Monitoring* course
- Pinellas County - 24-Hr. *Advanced Hazmat IQ* Course and 40-Hr. *Hazmat Medic* Course (both courses are to be implemented as a 50/50 cost share between LEPC and Pinellas County)
- City of Tampa - 3-Hr. *Hydro Carbon* Course
- ALL Jurisdictions - 8-Hr. *Street Smart for Hazmat* Course

Pursuant to HMEP Contract requirements, each HMEP-funded training event must be dedicated for public-sector first responders, must be pre-approved by FDEM/USDOT, must meet FDEM's cost effectiveness criteria, and be transportation-related or include a transportation component or nexus.

HMEP Training Subcommittee Chair James Johnston has scheduled a HMEP Training Subcommittee meeting on Wednesday, May 24, 2017 at the LEPC/TBRPC offices, one hour prior to the scheduled start of the LEPC quarterly meeting. The primary purpose of the meeting is to further progress towards scheduling the (above referenced) desired training courses, in association with the FY 2016-17 HMEP Training Program.
